Core academic subject area course work is found in elementary and early childhood programs. Candidates return early for extended practicum in the fall to see how teachers start the school year. The program includes a course in Students with Diverse Needs, a course module in ESOL taught by a TESOL professor, and a course module in Working with Children of Poverty. Professors go with candidates in the field to see, discuss, and reflect upon a wide variety of schools, including urban and rural schools. The program partnership with local public charter school creates opportunities for candidates to work with parents in a Literacy Night format. Candidates support the parents in providing parent instruction on areas related to literacy. During COVID 19, student teachers participated in online instruction in support of the schools and families. District school administrators, teachers, and university supervisors participate in Education Advisory Council meet to consider program changes to best prepare candidates to meet the needs of the districts/schools/families.

The program includes modules in technology in several classes, including integrating SMART Boards, ETV streaming video, etc. in lesson planning. Candidates are taught to integrate technology designed to engage learners (e.g., SMART Board, web-based Kahoot, Google Docs, etc.). Candidates implement assessment practices integrating technology for assessing student progress and for planning instruction based upon the assessment findings. The assessment course includes a project for pre/post test scores and standardized assessment scores for assessing student needs with the use of MS Excel. One unit in clinical practice requires a student learning project with pre/post-test data analysis for improvement of student learning. In numerous classes and practical training, students are encouraged to provide information in a variety of ways, monitor for student engagement, and maintain high expectations for all students. Candidates work with a Unit Work Sample (UWS) prior to student teaching and then analyze student growth and/or weak areas of Student Learning Outcomes (SLOs) in a unit of study integrating technology.

Candidates have a required course (EDU 5810 Students with Diverse Needs) focusing on teaching early childhood and elementary students with various learning needs, including gifted students as well as disabled students. Candidates role play an IEP meeting with a parent. Additionally, candidates receive instruction (EDU 5541 Learning Environment and Classroom Management) in building a learning environment conducive for meeting the needs of students with disabilities. Additionally, all lesson plans in the program are reviewed and scored as to the candidates' support for the student learning needs.

b. Participate as a member of individualized education program teams, as defined in section 614(d)(1)(B) of the *Individuals with Disabilities Education Act*.

Candidates in EDU 5810 Students with Diverse Needs watch an IEP meeting modeled and then are required to participate in a mock IEP team meeting where parents of children with disabilities are brought in to participate. As opportunities arise, candidates participate in IEP meetings in their student teaching experience.

Candidates receive specific instruction for working with ELL (EDU 5603 Instructional Practices for Literacy and Technology). A course module in ESOL is taught by a TESOL professor who also brings in a district TESOL person. Candidates are required to develop an ELA lesson plan with a specific focus on the diverse learning needs discussed during the ESOL section of the course. Additionally, all lesson plans in the program are reviewed and scored as to the candidates' support for the student learning needs.
